**Protection from your spouse's debts**

When you file a joint tax return, the law may protect you from having to pay for liabilities for which your spouse (or former spouse) is responsible.

**Innocent spouse relief**

If your spouse is responsible for an incorrect item or an underpayment of tax on your joint tax return, you may be eligible for innocent spouse relief. This could change the amount you owe, or you may be entitled to a refund.

Note: You must submit a claim no later than two years from the date of our first attempt to collect the outstanding debt. This notice is an example of an attempt to collect, although it might not be our first attempt to collect.

**Injured spouse relief**

You may be eligible for injured spouse relief if some or all of your overpayment has been (or will be) applied to pay your spouse's past-due income taxes and other debt (child support, spousal support, student loans). You may be entitled to a refund for your share of an overpayment that's been applied to your spouse's debt.
